SECOND DRAW LOAN CHECKLIST

Please submit the following documents with your Second Draw loan application for the Paycheck Protection Program.

Partnership With Employees

PAYROLL DOCUMENTS

2019 or 2020 IRS Form 1065 (including Schedule K-1)

2019 or 2020 IRS Forms 941 from each quarter (alternatives listed below)

For very small businesses, use Form 944

For farmers/ranchers, use Form 943

Forms W-2 and W-3

Payroll processor reports, including quarterly and annual tax reports

DOCUMENTS TO ESTABLISH BUSINESS OPERATIONS AS OF FEBRUARY 15, 2020

Payroll statement or similar documentation from the pay period covering February 15, 2020 (if Q1 2020 941 is provided, additional documentation is not necessary).

If your loan amount is over \$150,000, please refer to the checklist [Additional Requirements for Loans over \\$150,000](#). If your loan amount is \$150,000 or under, you do not need to provide revenue reduction documents at this time.
